**DEADLINE FOR MEMBERSHIP APPLICATION IS NOVEMBER 1, 2010.** The applications must be received by this date. They need to be forwarded on to the NHSRA office before you are an official member. Before your application can be processed you must include:

- 1) The 2 application forms, front & back. **The minor release form must be signed by parents or a legal guardian, the member and it must be notarized.** Please note: **All three people must appear before the notary!!** If you have sole custody or one parent is deceased, write that in.
- 2) A copy of your **current report card**. These requirements are mandated by the National High School Rodeo Association as printed on pages 26 - 29 of the National Rulebook
- 3) Home schooled **exemption certificate**, if you are home schooled.
- 3.) **\$147.00 FEE** paid by **cashiers check or money order** made payable to the SDHSRA. The \$147.00 fee is divided as follows: \$23.00 membership dues in the SDHSRA, \$33.00 membership dues in the NHSRA, \$15.00 for the NHSRA Times, \$2.00 for the Western Horseman Subscription and \$74.00 for medical insurance. The insurance must be purchased. If the five items listed above are not complete your application will be returned.
